**PLEASE TAKE NOTICE** that any qualified elector of the City of Wixom who is not already registered may register to vote at the office of the City Clerk, the office of the County Clerk, a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at [mi.gov/vote](http://mi.gov/vote) and mailed to the City Clerk. Voters who are already registered may update their registration at [www.expressSOS.com](http://www.expressSOS.com).

The last day to register in any manner other than in-person with the local clerk is Monday, October 21, 2024.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL168.492) at the City Clerk's office located at 49045 Pontiac Trail, Wixom, MI 48393 at the following times:

- Regular business hours: Monday through Thursday from 7:15 a.m. to 5:30 p.m.
- Saturday, November 2, 2024 from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday, November 5, 2024, from 7:00 a.m. to 8:00 p.m.
